7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Executive,**
9 **Department of Environmental Services, to hire a total of two external persons into part-**
10 **time, bargaining unit, unclassified, Computer Monitor Aide positions, for the Executive's**
11 **Department of Environmental Services, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
14 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled "Temporary
15 Hiring Freeze," to control and reduce the County's budget deficit; and

16
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a resolution authorizing the office to hire
20 said employees; and

22 WHEREAS, the Executive states that the positions of Computer Monitor Aide has been
23 posted three times internally, and that his office has not been able to hire a qualified candidate,
24 and that it is necessary for the continued and effective operation of his office to be permitted to
25 hire and fill two part-time Computer Monitor Aide positions; and

27 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
28 is necessary and in the best interest of the County of Summit to authorize the County Executive
29 to hire two external people into part-time, bargaining, classified Computer Monitor Aide
30 positions;

32 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
33 State of Ohio, that:

37 County Council hereby determines that the County Executive's Department of
38 Environmental Services has demonstrated that it is necessary for the effective and continued
39 operation of that office to authorize the County Executive, pursuant to Section 169.04(j) of the
40 Codified Ordinance, to hire two external persons into part-time, bargaining, unclassified
41 Computer Monitor Aide positions.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the citizens of the County of Summit and for the further reason to immediately
47 authorize the County Executive to hire said individuals in order to continue effectively operate
48 the Department of Environmental Services.
