7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Ohio Emergency Management Agency of a Fiscal Year 2011**  
9 **Statewide Search and Rescue Capability grant, for the period 7/1/10 through 6/30/11, in the**  
10 **amount of \$10,000.00, with no local cash match requirement, and appropriating these**  
11 **funds for Region 5 expenditures through 6/30/11, for the Executive's Department of Public**  
12 **Safety – Emergency Management Agency and declaring an emergency.**

14 WHEREAS, the Ohio Emergency Management Agency has granted a Fiscal Year 2011  
15 Statewide Search and Rescue Capability award in non-federal funds in the amount of \$10,000.00  
16 for the period 7/1/10 through 6/30/11, with no local cash match requirement to the County of  
17 Summit Emergency Management Agency (“EMA”); and

19 WHEREAS, the purpose of the Search and Rescue award is to support Ohio urban search  
20 and rescue programs statewide, and can include costs associated with team administration,  
21 purchase and maintenance of equipment, expendable materials and supplies, and exercises and  
22 training; and

24 WHEREAS, the Summit County EMA award is to be utilized to continue to build and  
25 sustain the Region #5 Type II collapse search and rescue capability and will fund materials and  
26 training for the Search and Rescue team; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
29 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
30 any documents necessary to accept the award of the aforementioned grant from the Ohio  
31 Emergency Management Agency, and to appropriate these Search and Rescue grant funds;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
34 of Ohio, that:

38 The County Executive is hereby authorized to execute any documents necessary to accept  
39 the Fiscal Year 2011 Statewide Search and Rescue Capability grant award from the Ohio  
40 Emergency Management Agency for the period 7/1/10 through 6/30/11, in the amount of  
41 \$10,000.00, with no local cash match requirement.
