8 **A Resolution adjusting the appropriations of funds from the Ohio Department of Job and**
9 **Family Services (“ODJFS”) for a net increase of Temporary Assistance for Needy Families**
10 **(“TANF”) federal funds in the amount of \$2,576,962.00, for services provided through**
11 **9/30/10, and adjusting existing Child Care appropriations for a net decrease of**
12 **\$19,346,557.00, for the period ending 12/31/10, for the Executive’s Department of Job and**
13 **Family Services (“SCDJFS”), and declaring an emergency.**

14
15 WHEREAS, in order to provide assistance to eligible families, SCDJFS has received
16 TANF federal funds annually on a State Fiscal Year (“SFY”), currently being twelve months
17 ending 6/30/10; and

18
19 WHEREAS, ODJFS has changed the award year to a Federal Fiscal Year (FFY) currently
20 being twelve calendar months ending 9/30/10, resulting in an additional three months in the
21 revised fiscal year of operation in 2010; and

22
23 WHEREAS, SCDJFS has received from ODJFS the TANF funds for this additional
24 quarter which must be appropriated for expenditures made through 9/30/10; and

25
26 WHEREAS, the SCDJFS appropriated twelve months of Child Care reimbursements to
27 child care vendors in the 2010 annual operating budget in Resolution No. 2009-469; and

28
29 WHEREAS, ODJFS changed the Child Care payment process, effective 7/1/10, sending
30 payment checks directly to vendors and no longer routing the payments through the local DJFS;
31 and

33 WHEREAS, because the County will no longer receive or disburse the child care
34 payments appropriated for the last six months of calendar year 2010, it is necessary to decrease
35 the remaining balance of the child care payment appropriations in the 2010 budget; and

37 WHEREAS, this Council has determined by reviewing all pertinent information that the
38 adjustments to the appropriation in the aforementioned funds are necessary and in the best
39 interest of the County of Summit;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

21 the appropriations to increase TANF funds and decrease Child Care funds are immediately
22 needed for the Executive's Department of Job and Family Services.

26 Provided this Resolution receives the affirmative vote of eight members, it shall take
27 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
28 effect and be in force at the earliest time provided by law.
