7 **A Resolution appropriating two Workforce Investment Act (“WIA”) National Emergency**
8 **Grant (“NEG”) awards received from the Ohio Department of Job and Family Services**
9 **(“ODJFS”), including \$100,000.00 for the Workforce Investment Act National Emergency**
10 **Grant OH-22 Replenishment Funds Allocation, and an additional \$302,030.00 American**
11 **Recovery and Reinvestment Act of 2009 (“ARRA”) grant for the current American**
12 **Recovery and Reinvestment Act National Emergency Grant OH-19 Automotive Dual**
13 **Enrollment program, through 12/31/10, for the Executive’s Department of Job and Family**
14 **Services and declaring an emergency.**

15
16 WHEREAS, the ODJFS Office of Workforce Development has awarded two additional
17 WIA NEG grants to the Executive’s Department of Job and Family Services; and

18
19 WHEREAS, the Executive’s Department of Job and Family Services is a recipient of
20 \$100,000.00 WIA NEG OH-22 Replenishment Fund grant award from ODJFS, which will be
21 effective 7/1/10 through 3/31/11, in order to provide training and/or services for dislocated
22 workers who are currently being served or on the waiting list for services; and

23
24 WHEREAS, the Executive’s Department of Job and Family Services is a recipient of two
25 increases totaling \$302,030.00, the first being \$112,330.00 and the second being \$189,700.00, to
26 its current WIA NEG OH-19 Automotive Dual Enrollment ARRA grant award from ODJFS,
27 which is effective from 4/1/09 through 3/31/11, to provide additional support to area workers
28 effected by shutdowns in the automotive industries; and

30 WHEREAS, this Council has determined by reviewing all pertinent information that it is
31 necessary and in the best interest of the County of Summit to appropriate the aforementioned
32 WIA NEG OH-22 funds in the amount of \$100,000.00, and to appropriate the aforementioned
33 WIA NEG OH-19 ARRA funds in the amount of \$302,030.00;
