7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Emdeon Business Services for the second and final renewal of the printing, stuffing and**  
9 **mailing for real estate, manufactured home tax bills and dog and kennel licenses, for the**  
10 **period 3/15/11 to 3/14/13, in an amount not to exceed \$470,856.40, for the Fiscal Officer,**  
11 **and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 11, 2010, awarded a  
14 purchase order to provide the aforementioned renewal, subject to confirmation by County  
15 Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that  
18 the purchase contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a purchase contract with Emdeon Business  
26 Services for the second and final renewal of the printing, stuffing and mailing for real estate,  
27 manufactured home tax bills and dog and kennel licenses, for the period 3/15/11 to 3/14/13, in an  
28 amount not to exceed \$470,856.40, is hereby confirmed and the County Executive is hereby  
29 authorized to execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide the aforementioned renewal.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.
