7 **A Resolution pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled “Temporary Hiring freeze,” to authorize the County Fiscal Officer to**  
9 **effectuate a transfer of an internal non-general fund County employee into the non-**  
10 **bargaining, classified position of Assistant Director of Administration, up to the midpoint**  
11 **of the pay range for the position, for the Accounting Department of the Fiscal Officer, and**  
12 **declaring an emergency.**

13  
14 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted  
15 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled “Temporary  
16 Hiring Freeze,” to control and reduce the County’s budget deficit; and

17  
18 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
19 the filling of an existing position by hiring an employee is necessary for the effective and  
20 continued operation of the office, Council may adopt a Resolution authorizing the office to hire  
21 said employees; and

23 WHEREAS, the County Fiscal Officer states that the non-bargaining, classified position  
24 of Assistant Director of Administration has been posted three consecutive days internally, and  
25 that his office has not been able to hire a qualified candidate, and that it is necessary for the  
26 continued and effective operation of his office to be permitted to hire and fill the position of  
27 Assistant Director of Administration; and

29 WHEREAS, this Council has determined, after reviewing all pertinent information, that it  
30 is necessary and in the best interest of the County of Summit to authorize the County Fiscal  
31 Officer to effectuate a transfer of an internal non-general fund County employee to fill the  
32 position of Assistant Director of Administration, up to the midpoint of the pay range for the  
33 position;

35 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

6 County Council hereby determines that the County Fiscal Officer's Department of  
7 Accounting has demonstrated that it is necessary for the effective and continued operation of that  
8 office to authorize the County Fiscal Officer, pursuant to Section 169.04(j) of the Codified  
9 Ordinance, to effectuate a transfer of an internal non-general fund County employee into the  
10 non-bargaining, classified position of Assistant Director of Administration, up to the midpoint of  
11 the pay range for the position.

13 SECTION 2

15 This Resolution is hereby declared an emergency in the interest of the health, safety and  
16 welfare of the citizens of the County of Summit and for the future reason to immediately  
17 authorize the County Fiscal Officer to transfer said individual in order to continue effectively  
18 operate the Accounting Department.

20 SECTION 3

22 Provided this Resolution receives the affirmative vote of eight members, it shall take  
23 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect  
24 and be in force at the earliest time provided by law.

28 It is found and determined that all formal actions of this Council concerning and relating  
29 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
30 deliberations of this Council and of any of its committees that resulted in such formal action,  
31 were in meetings open to the public, in compliance with all legal requirements, including Section  
32 121.22 of the Revised Code.
