7 **A Resolution confirming an award by the Board of Control of a lease agreement with Fred**
8 **Martin Motor Company to provide seven vehicles for the Drug Unit, for the period 9/1/10**
9 **through 8/31/12, in an amount not to exceed \$72,000.00 for two years (\$3,000.00 per month), as**
10 **Best Practical Source, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held September 15, 2010, has awarded a
13 two-year lease for seven vehicles, subject to confirmation by County Council; and,

15 WHEREAS, County Council has determined by reviewing all pertinent information that the
16 lease agreement is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of
19 Ohio, that:

21 SECTION 1

23 The award by the Board of Control of a lease agreement with Fred Martin Motor Company
24 to provide seven vehicles for the Drug Unit, for the period 9/1/10 through 8/31/12, in an amount not
25 to exceed \$72,000.00 for two years (\$3,000.00 per month), as Best Practical Source, is hereby
26 confirmed, and the County Executive is authorized to execute such lease agreement.

30 This resolution is hereby declared an emergency in the interest of the health, safety, and
31 welfare of the citizens of the County of Summit, and for the further purpose of immediately
32 providing undercover vehicles for the Sheriff's Drug Unit.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
37 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in
38 force at the earliest time provided by law.

42 It is found and determined that all formal actions of this Council concerning and relating to
43 the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action, were in

46 the Ohio Revised Code.
