7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Sheriff to hire a**
9 **total of two external persons into part-time, bargaining unit Communication Technician 1**
10 **positions, at salary of \$14.05 per hour, for an estimated cost for both part-time positions of**
11 **\$46,758.00 annually, for the Sheriff, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
14 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled "Temporary
15 Hiring Freeze," to control and reduce the County's budget deficit; and

16
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
20 said employees; and

22 WHEREAS, the County Sheriff states that the positions of Communications Technicians
23 I has been posted two times internally, and that his office has not been able to hire a qualified
24 candidate, and that it is necessary for the continued and effective operation of his office to be
25 permitted to hire and fill two part-time, bargaining unit Communications Technicians I positions
26 at salary of \$14.05 per hour, for an estimated cost for both part-time positions of \$46,758.00
27 annually; and

29 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
30 is necessary and in the best interest of the County of Summit to authorize the Sheriff to hire two
31 external people into part-time, bargaining unit Communications Technicians I positions;

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
34 State of Ohio, that:

38 County Council hereby determines that the County Sheriff's Department has
39 demonstrated that it is necessary for the effective and continued operation of that office to
40 authorize the County Sheriff, pursuant to Section 169.04(j) of the Codified Ordinances, to hire
41 two external persons into part-time, bargaining unit Communications Technicians I positions at
42 salary of \$14.05 per hour, for an estimated cost for both part-time positions of \$46,758.00
43 annually.

47 This Resolution is hereby declared an emergency in the interest of the health, safety and
48 welfare of the citizens of the County of Summit and for the further reason to immediately
49 authorize the Sheriff to hire two external persons into part-time, bargaining unit Communications
50 Technicians I positions in order to continue to effectively operate the Sheriff's Office.
