7 **A Resolution authorizing the County Executive to execute a contract, subject to the**  
8 **approval of the Board of Control, with Guardian Life Insurance Company to provide**  
9 **voluntary dental insurance for County employees, for the period 1/1/11 through 12/31/11,**  
10 **in an amount not to exceed the single rate of \$25.29 per month and the family rate of \$74.93**  
11 **per month, for an estimated total not to exceed amount of \$1,064,593.00 for 2011, with two**  
12 **options to renew for an additional one-year term, for the Executive's Department of**  
13 **Insurance and Risk Management, and declaring an emergency.**

15 WHEREAS, after issuing a request for proposals, the County of Summit has selected  
16 Guardian Life Insurance Company to provide voluntary dental insurance for County employees,  
17 for the period 1/1/11 through 12/31/11, in an amount not to exceed the single rate of \$25.29 per  
18 month and the family rate of \$74.93 per month, for an estimated total not to exceed amount of  
19 \$1,064,593.00 for 2011, with two options to renew for an additional one-year term; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that  
22 authorizing the County Executive to execute the aforementioned contract, subject to the approval  
23 of the Board of Control, is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is hereby authorized to execute to execute a contract, subject to  
31 the approval of the Board of Control, with Guardian Life Insurance Company to provide  
32 voluntary dental insurance for County employees, for the period 1/1/11 through 12/31/11, in an  
33 amount not to exceed the single rate of \$25.29 per month and the family rate of \$74.93 per  
34 month, for an estimated total not to exceed amount of \$1,064,593.00 for 2011, with two options  
35 to renew for an additional one-year term.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 authorize the Executive to execute a contract to provide voluntary dental insurance to County  
42 employees.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
