7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an Akron Community Foundation (“ACF”) award of an Arthur Kelly Fund**
9 **Domestic Violence Training Grant in the amount of \$4,000.00, with no local cash match**
10 **requirement, and appropriating these funds for the Prosecutor’s Domestic Violence**
11 **Program expenditures through 12/31/10, for the Prosecutor, and declaring an emergency.**

13 WHEREAS, the Prosecutor’s Criminal Division received federal funding from the U.S.
14 Department of Justice, which was appropriated in Resolution No. 2010-013, for the support of a
15 Domestic Violence Unit; and

17 WHEREAS, the Prosecutor has received an ACF award of an Arthur Kelly Fund
18 Domestic Violence Training Grant in the amount of \$4,000.00, with no local cash match
19 requirement, to supplement the Domestic Violence Unit Program; and

21 WHEREAS, the Prosecutor will use the Arthur Kelly Fund Domestic Violence Training
22 Grant to support a part-time student helper to coordinate training and maintain records for the
23 Domestic Violence Unit; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is
26 necessary and in the best interest of the County of Summit to authorize the Executive to execute
27 any documents necessary to accept the award of the aforementioned grant from the ACF, and to
28 appropriate these Arthur Kelly Fund Domestic Violence Training grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 the Arthur Kelly Fund Domestic Violence Training Grant award from the Akron Community
37 Foundation, awarded 9/17/10, in the amount of \$4,000.00, with no local cash match requirement.

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason to immediately authorize the Executive to execute any documents necessary to accept the award of an ACF grant and to appropriate the Arthur Kelly Fund Domestic Violence Training grant funds.
