7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Public Safety, for a High Visibility**
9 **Enforcement Overtime (“HVEO”) grant in the amount of \$71,087.00, with no local cash**
10 **match requirement, for the period 10/1/10 to 9/30/11, and appropriating the grant funds**
11 **for the period 10/1/10 through 12/31/10, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Public Safety, through the Ohio Traffic Safety
14 Office (“OTSO”), offers funding for an HVEO grant program in Summit County; and

16 WHEREAS, the Sheriff has been awarded Grant #HVEO-2010-77-00-00-00554-00, in
17 the amount of \$71,087.85. with no local cash match requirement, from the Ohio Department of
18 Public Safety, for an HVEO grant to fund overtime work in order to conduct high visibility
19 enforcement, public awareness, and education in Summit County; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that
22 authorizing the County Executive to execute any documents necessary to accept the
23 aforementioned grant and the appropriations of the aforementioned grant funds is necessary and
24 in the best interest of the County of Summit;
