7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Cooks Direct, Inc., for Jail inmate kitchen equipment, in an amount not to exceed**
9 **\$134,818.90, for the Sheriff, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held November 10, 2010, awarded a
12 purchase contract to provide the aforementioned equipment, and to reject the lowest bid from
13 Eastbay Restaurant Supply due to non-responsiveness, subject to confirmation by County
14 Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase contract with Cooks Direct, Inc., for
25 Jail inmate kitchen equipment, in an amount not to exceed \$134,818.90, is hereby confirmed and
26 the County Executive is hereby authorized to execute such purchase contract.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned equipment.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,

46 121.22 of the Ohio Revised Code.
