7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Arcadis U.S., Inc., for engineer load rating for multiple bridges, in an amount**
9 **not to exceed \$38,079.00, for the Summit County Engineer, in Council Districts 1, 2, 4, 5, 7**
10 **and 8, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held November 24, 2010, awarded a
13 contract to provide the aforementioned services, subject to confirmation by County Council; and,

15 WHEREAS, County Council has determined by reviewing all pertinent information that
16 the contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
19 of Ohio, that:

23 The award by the Board of Control of a professional service contract with Arcadis U.S.,
24 Inc., for engineer load rating for multiple bridges, in an amount not to exceed \$38,079.00, in
25 Council Districts 1, 2, 4, 5, 7 and 8, is hereby confirmed and the County Executive is hereby
26 authorized to execute such contract.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned services.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,

46 121.22 of the Ohio Revised Code.


