7 **A Resolution authorizing the County Executive to advertise for bids for the five-year full**
8 **maintenance service contract for Heating, Ventilation and Air Conditioning (“HVAC”) at**
9 **the Ohio Building complex, in Council District 4, for an estimated total cost not to exceed**
10 **\$125,000.00, for the Executive’s Department of Administrative Services-Physical Plants,**
11 **and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council’s authorization for the County Executive to advertise for bids; and

15
16 WHEREAS, the County Executive wishes to advertise for bids for the five-year full
17 maintenance service contract for HVAC at the Ohio Building complex, in Council District 4, for
18 an estimated total cost not to exceed \$125,000.00; and

20 WHEREAS, a copy of the bid package is on file in the office of the Clerk of Council; and

22 WHEREAS, the cost of the aforementioned contract shall be paid from the 2011 Physical
23 Plants Contract Services budget line item; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that is
26 necessary and in the best interest of the County of Summit to authorize the Executive to advertise
27 for bids for the aforementioned contract;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

34 The County Executive is authorized to advertise for bids for the five-year full
35 maintenance service contract for Heating, Ventilation and Air Conditioning (“HVAC”) at the
36 Ohio Building complex, in Council District 4, for an estimated total cost not to exceed
37 \$125,000.00.

41 This Resolution is declared an emergency in the interest of the health, safety, and welfare
42 of the citizens of the County of Summit, and for the further reason that it immediately authorizes
43 the Executive to advertise for bids for the five-year full maintenance service contract for HVAC
44 at the Ohio Building complex, in Council District 4, in order to meet appropriate deadlines for
45 this contract.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
