7 **A Resolution authorizing the County Executive to execute a grant agreement with the**  
8 **Summit County Combined General Health District ("SCCGHD") for the employment of a**  
9 **Medical Reserve Corps Coordinator, from 1/1/11 through 12/31/11, for an amount not to**  
10 **exceed \$67,869.01, to be paid from the Fiscal Year 2009 State Homeland Security Program**  
11 **("FY09 SHSP"), for the Executive's Department of Law, Division of Public Safety-**  
12 **Emergency Management Agency, and declaring an emergency.**

13  
14 WHEREAS, the Medical Reserve Corp ("MRC") is a national program, in partnership  
15 with the local public health community for the administration, recruiting and sustaining of  
16 medical volunteers to be used in times of disaster; and

17  
18 WHEREAS, funds have been appropriated for an SHSP grant to be used for contract  
19 services with the SCCGHD for funding an MRC Coordinator from 1/1/11 through 12/31/11; and

20  
21 WHEREAS, the SCCGHD seeks to employ an MRC Coordinator and wishes to execute a  
22 grant agreement with the County to fund the position from 1/1/11 through 12/1/11; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
25 necessary and in the best interest of the County of Summit to authorize the County Executive to  
26 execute the aforementioned grant agreement with the SCCGHD;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 The County Executive is hereby authorized to execute a grant agreement with the  
34 Summit County Combined General Health District ("SCCGHD") in the amount of \$67,869.01 to  
35 be paid from the Fiscal Year 2009 State Homeland Security Program ("FY09 SHSP").

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit and for the further reason of immediately  
41 contracting with the SCCGHD for the employment of a Medical Reserve Corps Coordinator  
42 from 1/1/11 through 12/1/11.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
