25 The award by the Board of Control of a purchase order with Proware for the second and
26 final renewal of case management system software support and maintenance services, for the
27 period 1/1/11 to 12/31/11, approved by the IT Board 11/9/10, in an amount not to exceed
28 \$137,026.00, is hereby confirmed and the County Executive is hereby authorized to execute such
29 purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned services.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
