7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award by the United States Department of Justice, Bureau of Justice Assistance,**  
9 **Fiscal Year 2010 State Criminal Alien Assistance Program (“FY10 SCAAP”) grant award**  
10 **of \$45,051.00, with no local cash match requirement, and appropriating these funds for**  
11 **expenditures in 2011, for the Executive’s Department of Law, Division of Public Safety–**  
12 **Justice Affairs, and declaring an emergency.**

13  
14 WHEREAS, through the SCAAP passed by Congress, the Office of Justice Affairs in the  
15 U.S. Department of Justice annually grants funding to jurisdictions for legitimate incarceration  
16 costs incurred as a direct result of the federal government’s failure to secure the border; and

17  
18 WHEREAS, Summit County has received grant funding which may only be used for  
19 correctional purposes such as certain construction, certain training and/or education for  
20 offenders, and/or specialized training or wages for corrections officers; and

21  
22 WHEREAS, the U.S. Bureau of Justice has awarded Summit County a FY10 SCAAP  
23 grant in the amount of \$45,051.00, with no local cash match requirement; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
26 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
27 any documents necessary to accept the award of the aforementioned grant from the Department  
28 of Justice;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept  
36 the Fiscal Year 2010 State Criminal Alien Assistance Program (“FY10 SCAAP”) grant award  
37 from the U.S. Department of Justice, Bureau of Justice Assistance, in the amount of \$45,051.00,  
38 with no local cash match requirement.

17 accepting and appropriating the FY10 SCAAP grant fund award.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take  
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
22 effect and be in force at the earliest time provided by law.

26 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
27 deliberations of this Council and of any of its committees that resulted in such formal action,
