7 **A Resolution appropriating funds for the third year of a three-year Felony Drug Court**
8 **Enhancement Grant from the U.S. Department of Health and Human Services Substance**
9 **Abuse and Mental Health Services Administration ("SAMHSA"), with no local cash match**
10 **requirement, for an Oriana House, Inc., program, in the amount of \$264,966.00, for the**
11 **period beginning 1/1/11 and ending 9/29/11, for the Court of Common Pleas-General**
12 **Division, and declaring an emergency.**

14 WHEREAS, the County of Summit received an award from the U.S. Department of
15 Health and Human Services SAMHSA, which was previously adopted by Resolution No. 2008-
16 503, for the period that would extend through 9/29/11, to provide case management services
17 through Oriana House, Inc.; and

18
19 WHEREAS, Resolution No. 2008-503 appropriated \$265,757.00 for the initial 2009
20 contract period, and Resolution No. 2010-254 appropriated \$265,757.00 for the second year of
21 the Oriana House case management services; and

23 WHEREAS, the balance of \$264,966.00 for case management services remains to be
24 appropriated for the final period of 1/1/11 through 9/29/11; and

26 WHEREAS, the case management services provided by Oriana House, Inc., will enhance
27 the treatment services for drug-related offenders; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is
30 necessary and in the best interest of the County of Summit to appropriate the aforementioned
31 funds in the amount of \$264,966.00;
