7 **A Resolution authorizing the County Executive to execute an Agreement with the Village of**
8 **Silver Lake, setting forth the scope of duties, manner of performance and all essential**
9 **terms and conditions whereby the County shall enforce Part Thirteen of the Codified**
10 **Ordinances of the County of Summit, entitled "Building Code", which incorporates the**
11 **2006 Residential Code of Ohio and the 2007 Ohio Building Code, on behalf of and within**
12 **the territorial jurisdiction of the Village of Silver Lake, for the Executive's Department of**
13 **Community and Economic Development, and declaring an emergency.**

14
15 WHEREAS, the State of Ohio, in the interest of providing building regulations
16 throughout the State of Ohio, has adopted the 2006 Residential Code of Ohio, which regulates
17 residential structures, and the 2007 Ohio Building Code, which regulates non-residential
18 structures, to provide uniform standards and requirements relating to the erection, construction,
19 repair, alteration and maintenance of residential and non-residential buildings within the State of
20 Ohio; and

22 WHEREAS, the County of Summit Department of Building Standards, through Part
23 Thirteen of the Codified Ordinances of the County of Summit, entitled "Building Code"
24 (hereinafter "County Building Code") has adopted the residential and non-residential building
25 regulations which incorporates both the 2006 Residential Code of Ohio and the 2007 Ohio
26 Building Code; and

28 WHEREAS, the County of Summit Department of Building Standards has been certified
29 by the State of Ohio Board of Building Standards to exercise enforcement, inspecting and
30 permitting authority pursuant to the County Building Code on behalf of and within townships
31 and certain municipalities throughout the County; and

33 WHEREAS, the Village of Silver Lake desires to enter into an Agreement with the
34 County of Summit setting forth the scope of duties, manner of performance and all essential
35 terms and conditions whereby the County Department of Building Standards shall enforce the
36 County Building Code on behalf of and within the territorial jurisdiction of the Village of Silver
37 Lake, and whereby the County Department of Building Standards shall have authority to (i)
38 accept and approve plans and specifications for residential and non-residential buildings, (ii)
39 permit the erection, construction, repair and alteration of residential and non-residential
40 buildings, (iii) inspect the erection, construction, repair and alteration of residential and non-
41 residential buildings, (iv) enforce the provisions of the County Building Code as they pertain to
42 residential and non-residential buildings, and

44 WHEREAS, it is anticipated that the Ohio Board of Building Standards will grant an
45 application of the Village of Silver Lake for certification of the County of Summit Department of
46 Building Standards pursuant to Section 3781.10(A) of the Ohio Revised Code to enforce the
47 County Building Code, on behalf of and within the territorial jurisdiction of the Village of Silver
48 Lake and to exercise all authority under Chapters 3781 and 3791 of the Ohio Revised Code on
49 behalf of the Village of Silver Lake effective on and after January 1, 2011; and

5 WHEREAS, given the uniformity of both the residential and non-residential building
6 codes throughout the State of Ohio with the adoption of the 2006 Residential Code of Ohio and
7 the 2007 Ohio Building Code, it will improve governmental efficiency and economy to
8 consolidate multiple governmental entities performing the same code enforcement functions
9 within the County; and

10
11 WHEREAS, this Council finds and determines after reviewing all pertinent information,
12 that it is necessary and in the best interest of the County to authorize the Executive to enter into
13 an Agreement with the Village of Silver Lake whereby the County shall enforce the County
14 Building Code on behalf of and within the territorial jurisdiction of the Village of Silver Lake.

16 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
17 of Ohio, that:

19 SECTION ONE

20
21 The County Executive is hereby authorized to enter into an Agreement with the Village
22 of Silver Lake setting forth the scope of duties, manner of performance and all essential terms
23 and conditions whereby the County Department of Building Standards shall enforce the County
24 Building Code on behalf of and within the territorial jurisdiction of the Village of Silver Lake,
25 and whereby the County of Summit Department of Building Standards shall have the authority to
26 (i) accept and approve plans and specifications for residential and non-residential buildings; (ii)
27 permit the erection, construction, repair and alteration of residential and non-residential
28 buildings; (iii) inspect the erection, construction, repair and alteration of residential and non-
29 residential buildings and (iv) enforce the provisions of the County Building Code as they pertain
30 to residential and non-residential buildings.

32 SECTION TWO

33
34 This Resolution is hereby declared to be an emergency in the interest of the health, safety
35 and welfare of the residents of the County of Summit and for the further reason that it will
36 immediately authorize the County Executive to execute said Agreement and allow the County of
37 Summit Department of Building Standards to begin enforcement of the County Building Code
38 on behalf of and within the territorial jurisdiction of the Village of Silver Lake on or before the
39 certification date of January 1, 2011, as set by the Ohio Board of Building Standards.

41 SECTION THREE

43 Provided this Resolution receives the affirmative vote of the eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
45 and be in force at the earliest time provided by law.
