7 **A Resolution appropriating funds currently received from fees paid by the partners at the**  
8 **County of Summit Workforce Investment Act ("WIA") One Stop facility for rent and**  
9 **occupancy costs in the amount of \$113,000.00 for the period ending 12/31/10, for the**  
10 **Executive's Department of Job and Family Services, and declaring an emergency.**

12 WHEREAS, the Executive's Department of Job and Family Services is the fiscal and  
13 administrative agent for the WIA Area 20 One Stops, that provide employment services in the  
14 Summit and Medina counties; and

15  
16 WHEREAS, the service-provider partners, including the State of Ohio Department of Job  
17 and Family Services ("ODJFS"), pay rent and a share of operating expenses ("rent") which are  
18 defined in a Memorandum of Understanding for their use of the One Stop facilities; and,

20 WHEREAS, actual rent collections from the partners to date exceed the amount  
21 appropriated in Resolution No. 2010-306; and

22  
23 WHEREAS, an additional appropriation of this funding is required to meet current 2010  
24 expense obligations; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
27 necessary and in the best interest of the County of Summit to appropriate the aforementioned  
28 funds in the amount of \$113,000.00;


