25 The award by the Board of Control of a purchase order with Central Flooring &
26 Acoustics, Inc., for removal and replacement of old flooring for the Fiscal Office Appraisal
27 Department, third floor lobby, and Homestead Department, under State Term Pricing, in an
28 amount not to exceed ~~\$61,184.97~~ \$62,549.28, is hereby confirmed and the County Executive is
29 hereby authorized to execute such purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned service.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
