**A Resolution authorizing the County Executive to execute a grant agreement with the Victim Assistance Program for personnel and/or supplies to assist in carrying out the purposes of the Domestic Violence Grant, for the period of 9/1/09 through 8/31/11, in an amount not to exceed \$68,193.00 (\$54,861.00 in salaries, \$10,832.00 in benefits and \$2,500.00 in travel/training), for the Prosecutor, and declaring an emergency.**

WHEREAS, in 2005, the County of Summit was awarded a Domestic Violence Grant from the Department of Justice's Office of Violence Against Women for the County Prosecutor's Domestic Violence Unit/Strategic At-Risk Family Education Program ("DVU/S.A.F.E. Program"), for the period of September 1, 2005 through August 31, 2007, in the amount of \$749,970.00, with no local cash match requirement; and

WHEREAS, the County has been awarded a two-year continuation of the Domestic Violence Grant, for the period of 9/1/09 through 8/31/11, in the amount of \$749,970.00, with no local cash match requirement; and

WHEREAS, this Council previously adopted Resolution No. 2009-374, which authorized the County Executive to execute any documents necessary to accept the Domestic Violence Grant; and

WHEREAS, the County wishes to enter into a grant agreement with the Victim Assistance Program for personnel and/or supplies to assist in carrying out the purposes of the Domestic Violence Grant, for the period of 9/1/09 through 8/31/11, in an amount not to exceed \$68,193.00 (\$54,861.00 in salaries, \$10,832.00 in benefits and \$2,500.00 in travel/training); and

WHEREAS, after reviewing all pertinent information, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned grant agreement with the Victim Assistance Program;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

#### SECTION 1

The County Executive is hereby authorized to execute a grant agreement with the Victim Assistance Program for personnel and/or supplies to assist in carrying out the purposes of the Domestic Violence Grant, for the period of 9/1/09 through 8/31/11, in an amount not to exceed \$68,193.00 (\$54,861.00 in salaries, \$10,832.00 in benefits and \$2,500.00 in travel/training).

#### SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately providing grant funds to the Victim Assistance Program for personnel and/or supplies to assist in carrying out the purposes of the Domestic Violence Grant.
