7 **A Resolution appropriating carryover grant funds received from the State of Ohio**
8 **Department of Rehabilitation and Correction through Community Corrections Act 407**
9 **and 408 Grants, in the amount of \$529,650.80, with no local cash match required, through**
10 **6/30/10, for the Executive's-Department of Law, Public Safety-Justice Affairs Division,**
11 **and declaring an emergency.**

13 WHEREAS, the State of Ohio Department of Rehabilitation and Corrections through the
14 Community Corrections Act ("CCA") 407 Grant makes funds available to assist community in
15 providing alternatives to prison for low risk offenders; and

16
17 WHEREAS, the State of Ohio Department of Rehabilitation and Corrections through the
18 CCA 408 Grant makes funds available to assist community in providing programs that will
19 reduce the reliance on the local jails; and

20
21 WHEREAS, the State of Ohio awarded the County of Summit both 407 and 408 Grants,
22 in the amount of \$529,650.80, with no local cash match required, through 6/30/10, which were
23 accepted by the County Executive and appropriated pursuant to Resolution No. 2009-306 and of
24 which \$180,650.80 remains available; and

26 WHEREAS, the State of Ohio made an additional award to the County of Summit of
27 both 407 and 408 CCA grant funds, with no local cash match required, through 6/30/10, which
28 were accepted by the County Executive and appropriated pursuant to Resolution No. 2009-496
29 and of which the full amount remains available; and

31 WHEREAS, these CCA grant awards provide funding to the Court of Common Pleas
32 Adult Probation Department, the Sheriff's Misdemeanor Residential and Jail Reduction
33 Programs and Oriana House Inc.; and

35 WHEREAS, this Council has determined by reviewing all pertinent information that it is
36 necessary and in the best interest of the County of Summit to appropriate the aforementioned
37 grant funds, in the amount of \$529,650.80;
