7 **A Resolution authorizing the County Executive to advertise for bids for the Q830 Warner**
8 **Road Trunk Line and Force Main Project, located in Council District 8, for the Executive's**
9 **Department of Environmental Services, and declaring an emergency.**

11 WHEREAS, the County Executive desires to advertise for bids for the Q830 Warner
12 Road Trunk Line and Force Main Project, located in District 8 in the City of Akron and the
13 Township of Coventry; and

14
15 WHEREAS, the County has determined the need to replace 840 linear feet of force main,
16 re-line approximately 2,274 linear feet of gravity sewer line, and rehabilitate 10 sanitary
17 manholes; and

19 WHEREAS, a copy of the bid specifications for said project are attached as Exhibit A
20 hereto and are on file in the Office of the Clerk of Council and at the Department of
21 Environmental Services State Road Office; and

23 WHEREAS, the Engineer estimates the total cost of said project to be an amount not to
24 exceed \$500,000.00; and

26 WHEREAS, this Council has determined that it is necessary and in the best interest of the
27 County of Summit to authorize the Executive to advertise for bids for the aforementioned
28 project;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to advertise for bids for a contract for the
36 Q830 Warner Road Trunk Line and Force Main Project, located in Council District 8. It is
37 estimated that the total project cost will not exceed \$500,000.00.

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and
42 welfare of the citizens of the County of Summit, and for the further reason that it will
43 immediately allow the County to obtain funds for a needed improvement.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
