8 **Job and Family Services (“ODJFS”) for the Workforce Investment Act (“WIA”) Rapid**
9 **Response allocation in the amount of \$605,778.73 through 6/30/10, for the Executive’s**
10 **Department of Job and Family Services and declaring an emergency.**

12 WHEREAS, additional federal funds in the amount of \$605,778.73 have been awarded to
13 the County of Summit from ODJFS for a WIA Rapid Response Program for the period 10/1/09
14 through 6/30/10; and

16 WHEREAS, this award will provide additional federal funding to the Executive’s
17 Department of Job and Family Services for Intensive Services, Supportive Services, and Training
18 Services to eligible WIA dislocated workers; and

20 WHEREAS, these funds are an additional award to the County’s existing allocation
21 which was appropriated as part of the County’s operating budget by Resolution No. 2009-469;

24 WHEREAS, this Council has determined by reviewing all pertinent information that it is
25 necessary and in the best interest of the County of Summit to appropriate the aforementioned
26 funds in the amount of \$605,778.73;


