7 **A Resolution confirming an award by the Board of Control of a purchase order with**  
8 **Instant Armor, Inc., for four Level III Tactical Blanket Support Systems, as Sole Source, in**  
9 **an amount not to exceed \$141,762.13, for the Executive's Department of Law – Public**  
10 **Safety Division, Emergency Management Agency, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 17, 2010, has awarded a  
13 purchase order for the aforementioned systems, as Sole Source, subject to confirmation by  
14 County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that  
17 the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with Instant Armor, Inc., for four  
25 Level III Tactical Blanket Support Systems, as Sole Source, in an amount not to exceed  
26 \$141,762.13, is hereby confirmed, and the County Executive is authorized to execute such a  
27 purchase order.

29 SECTION 2

31 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
32 welfare of the citizens of the County of Summit and for the further reason of immediately  
33 providing the aforementioned systems.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take  
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
39 effect and be in force at the earliest time provided by law.

43 It is found and determined that all formal actions of this Council concerning and relating  
44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
45 deliberations of this Council and of any of its committees that resulted in such formal action,  
46 were in meetings open to the public, in compliance with all legal requirements, including Section  
47 121.22 of the Ohio Revised Code.
