7 **A Resolution confirming an award by the Board of Control of a purchase order with Tyler**

10 **Board 2/16/10, in an amount not to exceed \$32,029.00, for the Fiscal Officer, and declaring**

13 WHEREAS, the Board of Control, at its meeting held February 17, 2010, has awarded a  
14 purchase order for software support, as Best Practical Source, subject to confirmation by County  
15 Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that  
18 the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a purchase order with Tyler Technologies for  
26 annual CRIS+plus software support for 35 users, for the period 4/24/10 to 4/23/11, as Best  
27 Practical Source, approved by the IT Subcommittee 2/11/10 and the IT Board 2/16/10, in an  
28 amount not to exceed \$32,029.00, is hereby confirmed, and the County Executive is authorized  
29 to execute such a purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
34 welfare of the citizens of the County of Summit and for the further reason of immediately  
35 providing such software support.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.
