A Resolution decreasing existing appropriations in the amount of \$1,986,800.00 within Workforce Investment Act ("WIA") Formulary funding, and increasing appropriations in the amount of \$276,346.90 in the WIA funding under the American Recovery and Reinvestment Act ("ARRA") of 2009, for a total net decrease of \$1,710,453.10, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2009-469, which approved the 2010 operating budget for the County of Summit which approved appropriations for WIA awards made to the Department of Job and Family Services; and

WHEREAS, the appropriation combined the WIA-Formulary funding with the WIA funding under the ARRA of 2009, and now requires an adjustment in order to separate these different funds, correct the award amount remaining available, and provide the necessary funding for services; and

WHEREAS, this Council has determined by reviewing all pertinent information that the adjustment of the appropriation of the aforementioned grant funds is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

WIA-Formula and WIA-Stimulus appropriations are hereby adjusted as follows:

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 5

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
