7 **A Resolution of support affirming the County of Summit's intent to provide an in-kind**
8 **match of 50% of the Assistant Recovery Coordinator's time related to the County of**
9 **Summit's co-application to the Economic Development Administration for an Economic**
10 **Adjustment grant, for the Executive's Department of Community and Economic**
11 **Development, and declaring an emergency.**

13 WHEREAS, the Public Works and Economic Development Act of 1965, 42 U.S.C.
14 Sections 3132-3233, as amended, delegates to the Economic Development Administration
15 (EDA) responsibility of assisting in the development of multi-county planning districts through
16 project grants which assure effective utilization of local resources in creating full-time permanent
17 jobs for the unemployed and the underemployed; and

18
19 WHEREAS, the purpose of the 1998 amendment to the Act was to further authorize
20 economic assistance in the form of planning, and implementation grants under Title I and II to
21 areas experiencing unemployment caused by structural changes in the area's economy; and

22
23 WHEREAS, the EDA is authorized through planning and implementation grants to assist
24 area planning efforts to solve problems of economic growth, unemployment and
25 underemployment; and

27 WHEREAS, this Council previously affirmed its support for a joint application by the
28 City of Twinsburg, with the County of Summit as co-applicant, to the Economic Development
29 Administration for Economic Adjustment Assistance in Resolution No. 2009-476; and

30
31 WHEREAS, the Economic Development Administration, as a condition to continuing
32 reviewing the Economic Adjustment application, has stated in writing to the Department of
33 Community and Economic Development their desire for a resolution confirming this Council's
34 intent to provide an in-kind match of 50% for the Assistant Recovery Coordinator's time; and

36 WHEREAS, this Council has determined by reviewing all pertinent information that it is
37 necessary and in the best interest of the County of Summit that the County of Summit affirms its
38 commitment to provide an in-kind match of 50% for the Assistant Recovery Coordinator's time;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

6 The County of Summit does hereby affirm its commitment to provide an in-kind match of
7 50%, as outlined in the grant application, for the Assistant Recovery Coordinator's time related
8 to the Economic Adjustment grant application submitted to the Economic Development
9 Administration by the City of Twinsburg and the County of Summit.

13 This Resolution is hereby declared an emergency in the interest of the health, safety, and
14 welfare of the citizens of the County of Summit and for the purpose of immediately declaring the
15 County's affirmation of its commitment to provide an in-kind match for the Assistant Recovery
16 Coordinator's time.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
