7 **A Resolution appropriating carryover grant funds received through the Ohio Department**
8 **of Youth Services for the Models for Change Program, in the amount of \$25,093.45**
9 **through 12/31/10, for the Juvenile Court, and declaring an emergency.**

11 WHEREAS, the County of Summit's Juvenile Court was selected in 2008 to participate
12 in the Models for Change Mental Health/Juvenile Justice Action Network supported in part by
13 the John D. and Catherine T. MacArthur Foundation with funds coming through the Ohio
14 Department of Youth Services; and

16 WHEREAS, County Council previously adopted Resolution No. 2008-517, which
17 authorized the County Executive to execute any documents necessary to accept funds through
18 the Models for Change Program, which focuses on system reform for mental health services for
19 juvenile justice involved youth and co-occurring disorders of mental health and substance
20 abuse, and appropriated and encumbered funds for the Program's three year duration; and

22 WHEREAS, some remaining purchase orders have been canceled making funds
23 available for the issuing of new purchase orders in the final year of operation in order to better
24 support the objectives of the Program; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to appropriate the aforementioned
28 funds, in the amount of \$25,093.45;
