7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a Fiscal Year 2009 (“FY09”) Metropolitan Medical Response System (“MMRS”)**
9 **award of \$321,221.00, federal homeland security pass-through funds from the Ohio**
10 **Emergency Management Agency (“OEMA”), with no local cash match requirement,**
11 **available through 7/31/12 for the Executive’s Division of Public Safety – Emergency**
12 **Management Agency, and declaring an emergency.**

13
14 WHEREAS, the OEMA has awarded a FY09 MMRS grant, in the amount of
15 \$321,221.00, with no local cash match requirement, to the County of Summit’s Emergency
16 Management Agency, for expenditures which are to enhance the capabilities of first responders
17 and receivers to emergency situations, through 7/31/12; and

19 WHEREAS, this FY09 MMRS grant will provide funds for activities within Summit
20 County and will be used to better mitigate, prepare, respond and recover from an act of terrorism
21 and other disasters within the medical and first responders community; and

23 WHEREAS, funds awarded under this program must directly support the Ohio
24 Investment Initiative as well as supporting Target Capabilities as approved by the U.S.
25 Department of Homeland Security; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is
28 necessary and in the best interest of the County of Summit to authorize the Executive to execute
29 any documents necessary to accept the award of the aforementioned grant from the Ohio
30 Emergency Management Agency;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to execute any documents necessary to accept
38 the award from the Ohio Emergency Management Agency of a FY09 MMRS grant, in the
39 amount of \$321,221.00, with no local cash match requirement.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit and for the further purpose of immediately
45 accepting the FY09 MMRS grant award.
