7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award by the Akron Community Foundation of a Millennium Fund for Children**
9 **grant in the amount of \$1,085.00, with no local cash match requirement, and appropriating**
10 **these funds for a vision screening and eyeglass program in 2010 for the Executives' Youth**
11 **Employment for Success Program, and declaring an emergency.**

13 WHEREAS, the County of Summit Youth Employment for Success ("YES") has been
14 awarded a Millennium Fund for Children grant by the Akron Community Foundation in the
15 amount of \$1,085.00, with no local cash match requirement, to provide a vision screening and
16 eyeglass program; and

18 WHEREAS, this YES program will provide vision screening to youths and follow-up
19 vision examinations and eyeglasses to those youths found to be in need; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that it is
22 necessary and in the best interest of the County of Summit to authorize the Executive to execute
23 any documents necessary to accept the award of the aforementioned grant from the Akron
24 Community Foundation, and to appropriate these grant funds;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
