7 **A Resolution approving the award by the Board of Control of a purchase contract with**  
8 **Thomson West for printed publications for the Law Library Resources Board in its**  
9 **operation of the Law Library, for 2010, in an estimated amount not to exceed \$21,261.50,**  
10 **as Best Practical Source, for the Law Library Resources Board, and declaring an**  
11 **emergency.**

13 WHEREAS, the Akron Law Library Association previously operated the Law Library,  
14 located on the 4<sup>th</sup> Floor of the County of Summit Courthouse; and

15  
16 WHEREAS, the Ohio General Assembly enacted 2008 Amended Substitute Ohio House  
17 Bill 420, which established county law library resource boards to operate law libraries; and

18  
19 WHEREAS, the County of Summit Law Library Resources Board took over operation of  
20 the Law Library on 1/1/10; and

21  
22 WHEREAS, as part of its operation, it is necessary for the Board to purchase printed  
23 publications; and

24  
25 WHEREAS, the Board of Control at its March 24, 2010 meeting awarded, subject to the  
26 approval of County Council, a purchase contract with Thomson West for printed publications for  
27 the Law Library Resources Board in its operation of the Law Library, for 2010, in an estimated  
28 amount not to exceed \$21,261.50, as Best Practical Source; and

29  
30 WHEREAS, contracts awarded to Thomson West on behalf of the Law Library  
31 Resources Board for calendar year 2010 exceed an aggregate of \$25,000.00, which requires the  
32 approval of Council; and

33  
34 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
35 necessary and in the best interest of the County to approve the award by the Board of Control of  
36 the aforementioned purchase contract to Thomson West; and

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
39 of Ohio, that:

41 SECTION 1

43 The award of a purchase contract with Thomson West for printed publications for the  
44 Law Library Resources Board in its operation of the Law Library, for 2010, in an estimated  
45 amount not to exceed \$21,261.50, as Best Practical Source, is hereby approved. The County  
46 Executive is hereby authorized to execute any documents necessary to approve the purchase by  
47 the Board of printed publications from Thomson West. A list of the printed publications and  
48 their estimated cost is attached hereto as Exhibit A and incorporated herein as if fully restated.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit and for the further purpose of immediately  
8 approving the award by the Board of Control of a purchase contract with Thomson West for the  
9 purchase of printed publications by the Law Library Resources Board in its operation of the Law  
10 Library.

12 SECTION 3

14 Provided this Resolution receives the affirmative vote of eight members, it shall take  
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
16 effect and be in force at the earliest time provided by law.

21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all

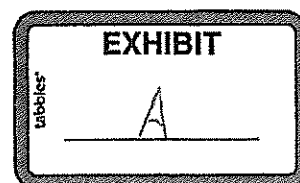
