7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **Montrose Auto Group for three 2010 Ford pick-up trucks, four 2011 Ford pick-up trucks**
9 **and one 2010 Ford Explorer, under CUE pricing, in an amount not to exceed \$179,315.94,**
10 **for the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held March 31, 2010, awarded a
13 purchase order to provide the aforementioned vehicles, subject to confirmation by County
14 Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with Montrose Auto Group for
25 three 2010 Ford pick-up trucks, four 2011 Ford pick-up trucks and one 2010 Ford Explorer,
26 under CUE pricing, in an amount not to exceed \$179,315.94, is hereby confirmed and the
27 County Executive is hereby authorized to execute such a purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned vehicles.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
