12 WHEREAS, the Board of Control, at its meeting held March 31, 2010, awarded a
13 contract to provide the aforementioned services, subject to confirmation by County Council; and,

16 the contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 The award by the Board of Control of a professional service contract with Hammontree
24 & Associates, Ltd., for design services for the East North Street Bridge Reconstruction, in an
25 amount not to exceed \$264,838.00, in Council District 2, is hereby confirmed and the County
26 Executive is hereby authorized to execute such contract.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned services.

37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.
