7 **A Resolution adjusting existing appropriations by \$65,000.00 for the Psycho-Diagnostic**
8 **Clinic for the period through 12/31/10, for the Summit County Court of Common Pleas,**
9 **and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2010-023, which
12 appropriated \$444,416.00 in funding from the County of Summit Alcohol, Drug Addiction and
13 Mental Health ("ADM") Board, which then awarded to the Court of Common Pleas Psycho-
14 Diagnostic Clinic to provide court-ordered evaluations in criminal cases; and

16 WHEREAS, these original appropriations were based on operational parameters used in
17 previous years which have now changed due to staffing vacancies and improvements in
18 operational efficiencies; and

20 WHEREAS, the \$65,000.00 in original appropriations require an adjustment in order to
21 provide services; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that the
24 adjustment of the appropriations of the aforementioned Psycho-Diagnostic Clinic fund is
25 necessary and in the best interest of the County of Summit;
