7 **A Resolution confirming an award by the Board of Control of a month to month lease with**
8 **Bridgestone Firestone for 4,666 square feet of office space for the Drug Unit Task Force,**
9 **for the period 1/1/10 to 12/31/10, in the amount of \$3,276.25 per month, for a total amount**
10 **not to exceed \$39,315.00, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 21, 2010, awarded a month
13 to month lease with Bridgestone Firestone for 4,666 square feet of office space for the Drug Unit
14 Task Force, for the period 1/1/10 to 12/31/10, in the amount of \$3,276.25 per month, for a total
15 amount not to exceed \$39,315.00, subject to confirmation by County Council; and

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the aforementioned lease is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a month to month lease with Bridgestone Firestone
26 for 4,666 square feet of office space for the Drug Unit Task Force, for the period 1/1/10 to
27 12/31/10, in the amount of \$3,276.25 per month, for a total amount not to exceed \$39,315.00, is
28 hereby confirmed and the County Executive is hereby authorized to execute such lease.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 authorize the Executive to execute the aforementioned lease.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
