7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award by the Public Utilities Commission of Ohio ("PUCO") of a Fiscal Year**
9 **2010 Hazardous Materials Training Grant for the Summit County Special Operations**
10 **Response Team, for the period 3/24/10 through 3/24/11, in the amount of \$9,600.00, with no**
11 **local cash match requirement, and appropriating these funds for training expenditures**
12 **through 12/31/10, for the Executive's Department of Law, Division of Public Safety -**
13 **Emergency Management Agency ("EMA"), and declaring an emergency.**

15 WHEREAS, the PUCO has awarded a Fiscal Year 2010 Training Grant to the Summit
16 County Special Operations Response ("HAZMAT") Team, for the period 3/24/10 through
17 3/24/11, in the amount of \$9,600.00, with no local cash match requirement, for HAZMAT
18 training expenditures for the County Executive's Department of Law; and

20 WHEREAS, this PUCO award will fund training on equipment (Hazcat) used to detect
21 hazardous materials, and is to be conducted by HazTech Systems to provide Hazcat Level 1
22 Refresher training to sixty fire service individuals; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that it is
25 necessary and in the best interest of the County of Summit to authorize the Executive to execute
26 any documents necessary to accept the award of the aforementioned grant from the PUCO, and
27 to appropriate these grant funds;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The County Executive is hereby authorized to execute any documents necessary to accept
35 the Fiscal Year 2010 Hazardous Materials Training Grant award from the PUCO for the period
36 3/24/10 through 3/24/11, in the amount of \$9,600.00, with no local cash match requirement.


