7 **A Resolution authorizing the County Executive, on behalf of the County, to act as a partner**
8 **in the Seasons Road Commerce Center - Ohio Job Ready Sites Project grant, by providing**
9 **sanitary sewer service to the Seasons Road Commerce Center as part of the City of**
10 **Hudson's grant application submitted to State of Ohio, Department of Development, in**
11 **Council District 3, for the Executive's Department of Environmental Services, and**
12 **declaring an emergency.**

14 WHEREAS, the State of Ohio, Department of Development, provides financial
15 assistance to local governments for the purpose of developing speculative sites for future
16 economic development opportunities through the Ohio Job Ready Sites grant; and

17
18 WHEREAS, the City of Hudson has submitted an application ("Application") to the Ohio
19 Department of Development Ohio Job Ready Sites program for financial assistance for the
20 creation of the Seasons Road Commerce Center in the area north of Seasons Road, between
21 Allen Road and Prosper Drive in the City of Hudson; and

23 WHEREAS, the provision of sanitary sewer service to the Seasons Road Commerce
24 Center is a necessary prerequisite for the State to award the Ohio Job Ready Sites Grant; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to authorize the County Executive, on
28 behalf of the County, to act as a partner in the Seasons Road Commerce Center by providing
29 sanitary sewer service to the Seasons Road Commerce Center as part of the grant application
30 submitted to Ohio Department of Development by the City of Hudson;

32 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive, on behalf of the County of Summit, is hereby authorized to act as
38 a partner in the Seasons Road Commerce Center - Ohio Job Ready Sites Project by providing
39 sanitary sewer service to the Seasons Road Commerce Center as part of the Application for
40 financial assistance submitted to State of Ohio, Department of Development by the City of
41 Hudson.

45 The Executive's Department of Environmental Services shall cooperate in providing all
46 information and documentation required by the State of Ohio, Department of Development with
47 regard to the Application.

7 welfare of the citizens of the County of Summit, and for the further purpose of immediately
8 authorizing the Executive, on behalf of the County, to act as a partner in the Seasons Road
9 Commerce Center by providing sanitary service as part of the Application.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive: otherwise, it shall take
15 effect and be in force at the earliest time provided by law.
