7 **A Resolution appropriating federal grant funds received as a result of the American**  
8 **Recovery and Reinvestment Act (“ARRA”) of 2009 from the Ohio Department of Job and**  
9 **Family Services, in the amount of \$2,266,474.00, for a summer youth employment program**  
10 **through 9/30/10, for the Executive’s Department of Job and Family Services, and declaring**  
11 **an emergency.**

12  
13 WHEREAS, on February 27, 2009, President Obama signed into law the American  
14 Recovery and Reinvestment Act of 2009 (“ARRA”), and, as a result of that law, the County has  
15 been the recipient of stimulus funds from the federal government; and

16  
17 WHEREAS, additional Temporary Assistance to Needy Families (“TANF”) ARRA  
18 funds have been awarded to the Executive’s Department of Job and Family Services to be made  
19 available for a Summer Youth Employment Program to be in operation in June, July and August  
20 of 2010; and

21  
22 WHEREAS, due to the short window of opportunity, being the summer months, these  
23 funds will be offered to vendors with prior experience in providing summer youth programs and  
24 the Executive’s Department of Job and Family Services will issue requests for proposals from  
25 all other vendors wishing to conduct a summer youth employment program; and

26  
27 WHEREAS, pursuant to Resolution No. 2009-088, the County Executive is authorized to  
28 execute any documents necessary to accept these additional ARRA funds, including executing  
29 and submitting a substantial amendment to the Annual Action Plan, but said funds must be  
30 appropriated prior to being spent; and

32 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
33 necessary and in the best interest of the County of Summit to appropriate the aforementioned  
34 ARRA funds, in the amount of \$2,266,474.00;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:


