7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **AraMark for food services to the Detention Center, for the period 7/1/10 to 6/30/11, with**
9 **four options to renew for a one-year period, at a cost of \$2.43 per meal and \$.50 per snack,**
10 **in a total amount not to exceed \$208,000.00, for the Juvenile Court, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 12, 2010, awarded a contract
14 to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase contract with AraMark for food
25 services to the Detention Center, for the period 7/1/10 to 6/30/11, with four options to renew for
26 a one-year period, at a cost of \$2.43 per meal and \$.50 per snack, in a total amount not to exceed
27 \$208,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
28 contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.


