7 **A Resolution confirming an award by the Board of Control of a first and final professional**  
8 **service contract renewal with Nordonia Hills Daycare and Preschool for drop-in child care**  
9 **services at the Job Center for all Summit County residents regardless of income, for the**  
10 **period 7/1/10 to 6/30/11, in an amount not to exceed \$75,000.00, for the Executive's**  
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 19, 2010, awarded a contract  
14 renewal to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that  
17 the contract renewal is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
20 of Ohio, that:

24 The award by the Board of Control of a first and final professional service contract  
25 renewal with Nordonia Hills Daycare and Preschool for drop-in child care services at the Job  
26 Center for all Summit County residents regardless of income, for the period 7/1/10 to 6/30/11, in  
27 an amount not to exceed \$75,000.00, is hereby confirmed and the County Executive is hereby  
28 authorized to execute such contract renewal.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and  
33 welfare of the citizens of the County of Summit, and for the further reason to immediately  
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take  
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including Section  
48 121.22 of the Ohio Revised Code.
