7 **A Resolution decreasing existing appropriations in the amount of \$179,623.00 within**
8 **Workforce Investment Act ("WIA") Formulary funding and increasing appropriations in**
9 **the amount of \$179,623.00 in WIA funding under the American Recovery and**
10 **Reinvestment Act of 2009, for the Executive's Department of Job and Family Services, and**
11 **declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2009-469 being the
14 2010 permanent budget for the County of Summit, which approved appropriations for various
15 WIA awards including two stimulus awards being a National Emergency Grant ("NEG") for
16 \$140,824.00 and a Rapid Response Grant for \$38,799.00 made to the Department of Job and
17 Family Services; and

19 WHEREAS, the appropriation combined the WIA-Formula funding with the WIA
20 stimulus funding under the WIA of 2009, and now requires an adjustment for the total of these
21 two awards being \$179,623.00 in order to separate these different funds, and provide the
22 necessary funding for services; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that the
25 adjustment of the appropriation of the aforementioned grant funds are necessary and in the best
26 interest of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:
