7 **A Resolution appropriating funds in the amount of \$141,672.11 in carryover balances for**
8 **2011, in the Emergency Management Agency fund and the Special Operations Response**
9 **Team fund, for the Executive's Department of Law, Division of Public Safety/Emergency**
10 **Management Division and declaring an emergency.**

12 WHEREAS, the County of Summit Emergency Management Agency has a carryover
13 balance in its operating fund from 2010 in the amount of \$32,121.58, which is required to
14 support the countywide emergency management preparedness drills, trainings, and resources,
15 including annual fees associated with the WebEOC and a countywide notification system, and

16
17 WHEREAS, the County Emergency Management Agency has a carryover balance in the
18 Special Operations Response Team fund from 2010 in the amount of \$109,550.53, which
19 supports and sustains the necessary equipment for the Summit County Special Operations
20 Response Teams, Hazmat Branch, Technical Rescue Branch and Water Rescue Branch
21 throughout Summit County; and

23 WHEREAS, it is necessary to appropriate these carryover funds from 2010 totaling
24 \$141,672.11 for 2011 operations; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that the
27 aforementioned appropriations in the amount of \$141,672.11 are necessary and in the best
28 interest of the County of Summit;
