7 **A Resolution appropriating carryover balances for two U.S. Department of Justice**
8 **Assistance Grant ("JAG Program Grants") made available by the State of Ohio Office of**
9 **Criminal Justice Services, through the American Recovery and Reinvestment Act of 2009**
10 **("ARRA"), for the Reentry Court Enhancement Grant, with a carryover balance,**
11 **including a 25% local cash match requirement, for a total of \$32,378.28, through 4/30/11,**
12 **and for the Probation Risk/Needs Assessment Grant, with a carryover balance, including a**
13 **25% local cash match requirement, for a total of \$6,192.67, through 2/28/11, for the Court**
14 **of Common Pleas, and declaring an emergency.**

15
16 WHEREAS, Resolution No. 2009-348 appropriated funding for two U.S. Department of
17 Justice ARRA JAG grants, from the State of Ohio Office of Criminal Justice, including the Adult
18 Probation Risk/Needs Assessment grant and the Reentry Court Enhancement grant, both with a
19 25% local cash match requirement, for the Court of Common Pleas; and

21 WHEREAS, the Reentry Court Enhancement grant has been extended to 4/30/11 and
22 requires appropriations of the carryover balance, including grant and match funds, for a total of
23 \$32,378.28; and

25 WHEREAS, the Adult Probation Risk/Needs Assessment grant has been extended to
26 2/28/11 and requires appropriations of the carryover balance, including grant and match funds,
27 for a total of \$6,192.67; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is
30 necessary and in the best interest of the County of Summit to appropriate the two aforementioned
31 ARRA JAG funds totaling \$38,570.95, received from the State of Ohio Office of Criminal
32 Justice Services;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State



32 121.22 of the Ohio Revised Code.


