7 **A Resolution authorizing the Executive to execute a lease agreement between the County of**  
8 **Summit and Congressman Tim Ryan, for approximately 200 square feet of office space at**  
9 **1040 East Tallmadge Avenue, Akron, Ohio, in Council District 2, for a two-year term, from**  
10 **1/3/11 through 1/2/13, at an annual rent of \$1.00 per year, for the Executive, and declaring**  
11 **an emergency.**

13 WHEREAS, the County owns real property located at 1040 East Tallmadge Avenue,  
14 Akron, Ohio; and

15  
16 WHEREAS, the County has previously leased office space at 1040 East Tallmadge  
17 Avenue, Akron, Ohio to Congressman Tim Ryan, who represents County residents in the United  
18 States House of Representatives; and

19  
20 WHEREAS, Congressman Ryan has used the space to service constituent concerns and  
21 needs, and the space is easily accessible to Summit County constituents of Congressman Ryan;  
22 and

24 WHEREAS, the County and Congressman Ryan desire to enter into a new lease for the  
25 aforementioned space for a two-year term, from 1/2/09 through 1/02/11, for an annual rent of  
26 \$1.00 per year; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
29 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
30 the aforementioned lease;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

35 SECTION 1

37 The County Executive is hereby authorized to execute a lease agreement between the  
38 County of Summit and Congressman Tim Ryan, for approximately 200 square feet of office  
39 space at 1040 East Tallmadge Avenue, Akron, Ohio, in Council District 2, for a two-year term,  
40 from 1/3/11 through 1/2/13, at an annual rent of \$1.00 per year.

44 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
45 welfare of the citizens of the County of Summit, and for the further reason of immediately  
46 permitting Congressman Tim Ryan to better serve the County's residents.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take  
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
52 effect and be in force at the earliest time provided by law.
