A Resolution authorizing the Executive to execute a lease agreement between the County of Summit and Congressman Tim Ryan, for approximately 200 square feet of office space at 1040 East Tallmadge Avenue, Akron, Ohio, in Council District 2, for a two-year term, from 1/3/11 through 1/2/13, at an annual rent of \$1.00 per year, for the Executive, and declaring an emergency.
WHEREAS, the County owns real property located at 1040 East Tallmadge Avenue, Akron, Ohio; and
WHEREAS, the County has previously leased office space at 1040 East Tallmadge Avenue, Akron, Ohio to Congressman Tim Ryan, who represents County residents in the United States House of Representatives; and
WHEREAS, Congressman Ryan has used the space to service constituent concerns and needs, and the space is easily accessible to Summit County constituents of Congressman Ryan; and
WHEREAS, the County and Congressman Ryan desire to enter into a new lease for the aforementioned space for a two-year term, from 1/2/09 through 1/02/11, for an annual rent of \$1.00 per year; and
WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned lease;
NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
SECTION 1
The County Executive is hereby authorized to execute a lease agreement between the County of Summit and Congressman Tim Ryan, for approximately 200 square feet of office space at 1040 East Tallmadge Avenue, Akron, Ohio, in Council District 2, for a two-year term, from 1/3/11 through 1/2/13, at an annual rent of \$1.00 per year.
SECTION 2
This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit, and for the further reason of immediately permitting Congressman Tim Ryan to better serve the County's residents.
SECTION 3
Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
