7 **An amended Resolution appropriating additional funds in the amount of \$72,200.00**
8 **\$170,000 for the Chrysler Rapid Response program, for the period 3/1/11 through 6/30/11**
9 **9/30/11, for the Executive's Department of Community and Economic Development, and**
10 **declaring an emergency.**

12 WHEREAS, the County Department of Job and Family Services and the Department of
13 Community and Economic Development entered into a Memorandum of Understanding
14 ("MOU") pursuant to which SCDCED is providing employment and skills counseling and
15 training opportunities to displaced workers, for the period 5/1/10 to 6/30/11, and anticipates
16 extending that MOU until 9/30/11, with funding provided by the Workforce Investment Act of
17 2009 Rapid Response Grant and the NEG ("National Emergency Grant"), for the Chrysler Rapid
18 Response program ("Project"); and

20 WHEREAS, the appropriations and MOU for the Project were legislated in Resolution
21 No. 2010-224, and subsequently the available carryover funds were appropriated in Resolution
22 No. 2011-079 for the period ending 6/30/11, and

24 WHEREAS, additional funds are required and available to provide for the Project's
25 operational costs associated with the final months of March 2011 through ~~June~~ September 2011;

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is
29 necessary and in the best interest of the County of Summit to appropriate the aforementioned
30 funds in the amount of ~~\$72,200.00~~ \$170,000.00;
