7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 (Office and Clerical) of the American**
9 **Federation of State, County and Municipal Employees, AFL-CIO, and the County Sheriff,**
10 **for the period 4/1/11 through 3/31/14, for the Executive and the Sheriff, and declaring an**
11 **emergency.**

13 WHEREAS, a collective bargaining agreement has been reached between the County
14 Sheriff and Ohio Council 8 and Local 1229 (Office and Clerical) of the American Federation of
15 State, County and Municipal Employees, AFL-CIO, for the period 4/1/11 through 3/31/14; and

17 WHEREAS, this Council has determined by reviewing all pertinent information that it is
18 the aforementioned collective bargaining agreement is necessary and in the best interest of the
19 County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The County Executive is hereby authorized to execute a collective bargaining agreement
27 between Ohio Council 8 and Local 1229 (Office and Clerical) of the American Federation of
28 State, County and Municipal Employees, AFL-CIO, and the County Sheriff, for the period
29 4/1/11 through 3/31/14.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit and for the for the further purpose of providing a
35 timely collective bargaining agreement between Ohio Council 8 and Local 1229 (Office and
36 Clerical) of the American Federation of State, County and Municipal Employees, AFL-CIO, and
37 the County Sheriff.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
50 were in meetings open to the public, in compliance with all legal requirements, including Section
51 121.22 of the Ohio Revised Code.


