34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit and for the for the further purpose of providing a
36 timely collective bargaining agreement between Ohio Council 8 and Local 1229
37 (Communications Technicians Unit) of the American Federation of State, County and Municipal
38 Employees, AFL-CIO, and the County Sheriff.


